HISTORY

The core of their practice was to provide legal advice to foreign investors who wished to expand their businesses into Greece. In 1938, after the passing of Constantinos Papapanos, the Firm's management was passed onto his close associate. Platon Tavlaridis, who diligently built a team of distinguished lawyers and expanded the Firm's client basis considerably. In 1980 Athanasios Tsimikalis took over the management of the Firm and in 1985 Chariklia Kalonarou joined as a partner. In 2011, it was registered in the Athens Bar association book of companies.

REAL ESTATE

The real estate market has always been extremely important for the Greek economy, as Greeks, by tradition, place their savings into real estate. Historically, this is due to the fact that for many decades, following World War 2, and in order to protect the national economy from inflation and the national currency from uncontrolled devaluation, the Greek state forbid transactions in gold and foreign currencies, and consequently the stock market remained, until the early 1990s, in an embryonic state. Hence the perception of many Greeks and foreign investors in Greece that the best way to invest money was to purchase real estate assets was created.

However the recent financial crisis has upset this long standing tradition underscoring the significant impact that fluctuations in the real estate market have on the economy. As the real estate market is trying to regain momentum, investors are once again moving into the Greek market. Our services cover the submission of applications to register trademarks, patents on inventions and designs, with either the Greek authorities or international organisations such as the European Trademark Office (OHIM), the European Patent Office (EPO) or the World Association for the Protection of Intellectual Property (WIPO). Trademarks

The high value of trademarks as an asset is undisputed. Indeed, there are not a few instances in which a trademark is a company's most valuable asset. Our services extend from handling trade mark portfolios, to the registration of trademarks and ensuring their judicial protection is secured.

The interplay of domain names with trademarks frequently creates a conflict of interests, owing to the different legal framework governing each of these rights. - Drafting concession documents

Patents
